Notice of Race and Sailing Instructions

1.0 Rules

- 1.1 The regatta will be governed by the 'rules' as defined in *The Racing Rules of Sailing*.
- 1.2 For Keel Yachts the YNZ Safety Regulations Part II, Category 4 shall apply.
- 1.3 For Trailer Yachts the YNZ Safety Regulations Part V, Category A shall apply.
- 1.4 For Sports Boats the YNZ Safety Regulations Part VI Category B shall apply. In addition, YNZ Safety Regulations Part V paragraphs 2.1 to 2.4 will apply to sports yachts.
- 1.5 For Ballasted Open Yachts not complying with Part II-IV of the YNZ Safety Regulations, Part I shall apply.
- 1.6 All yachts must be equipped with a VHF radio capable of transmitting and receiving on all channels. In addition, Sports yachts and Ballasted Open Yachts shall carry their VHF in a waterproof bag and be carried on one crew member
- 1.6 All yachts must be equipped with a VHF radio capable of transmitting and receiving on all channels.
- 1.7 No spinnakers, code zeros or extras may be set. Extras are defined as sails not normally used to advantage to windward. Headsails may be boomed out using spinnaker booms but shall only be carried on a permanent load bearing forestay with only one headsail per forestay.
- 1.8 A female must be at the helm for the entire race, including the pre-start, except as in 1.10 below.
- 1.9 The crew must be at least 50% female.
- 1.10 Should an emergency arise, the owner may take control to correct the situation. I.e. collision avoidance. The helm must be handed back as soon as reasonably possible.

2.0 Eligibility & Entry

- 2.1 Entries will be accepted from Keel Yachts, Multihulls and Trailer Yachts registered with YNZ and whose owners/skippers are financial members of a yacht club affiliated to YNZ.
- 2.2 Weiti Boating Club reserve the right to accept or refuse any entry.
- 2.3 Entries must be made to Weiti Boating Club using the online entry form on the Club's website. Entrants must provide a mobile phone number that they can be contacted on while racing.
- 2.4 There is **no entry fee** for this race.

4.0 Classes

- 4.1 All boats will race in one class and display a **Yellow** class flag.

5.0 Racing Area

- 5.1 The race will be held on the waters south of the Whangaparaoa Peninsula.
- 6.0 Course to be sailed**
- 6.1 The course will be a Triangular port course (as outlined in Appendix A.)
- 6.2 All races will start to windward.
- 7.0 The Start**
- 7.1 Races will be started using RRS 26 with the warning signal given 5 minutes before the starting signal.
- 7.2 The starting line will be between a pole flying an Orange flag on the Committee Boat at the starboard end and an orange conical buoy at the other. This flag (the “attention signal”) will be displayed with one sound signal, five minutes prior to the scheduled "warning signal" for the race. This instruction will not apply after a postponement, general recall or abandonment.
- 7.3 A yacht starting more than 10 minutes after her starting signal will be scored DNS (Did Not Start) This changes RRS A4.1 Low Point and Bonus Scoring Systems.
- 7.4 No engines shall be used after the preparatory signal for the race is given.
- 7.5 If any boat or part of a boat, or crew, is on the course side of the starting line at the starting signal and is identified, the race committee shall attempt to broadcast her number on VHF Ch 77. Failure to make a broadcast or to time it accurately will not be grounds for redress. This changes RRS 62.1.
- 8.0 The Finish**
- 8.1 The finish line will be between a pole on the Committee boat at the starboard end and an orange conical buoy at the port end.
- 9.0 Time Limit**
- 9.1 The time limit for the first boat to finish in each fleet is 150 minutes.
- 9.2 Boats failing to finish within 90 minutes after the first boat of its fleet sails the course and finishes will be scored DNF (Did Not Finish) This changes RRS 35, A4 and A5.
- 10.0 Protests and Requests for Redress**
- 10.1 Immediately after finishing, a boat intending to protest shall, in addition to fulfilling the requirements of RRS 61.1(a), (Informing the Protestee) inform the Committee Boat of her intention and the identity of the boat protested against and receive an acknowledgement from the Committee Boat.
- 10.2 For protests where only a rule of Part 2 (When boats Meet) is alleged to have been broken, an arbitration hearing will be offered prior to any hearing.
- 10.3 A protest shall be lodged on the appropriate form (available in the Club House) within the protest time limit and handed to a member of the sailing committee.
- 10.4 The time limit for lodging a protest is 120 minutes after the last boat of the final fleet has finished.
- 11.0 Safety Regulations**
- 11.1 A boat that retires from a race shall notify the Committee Boat immediately.
- 11.2 All entrants are required to register with the committee boat via VHF Radio before the warning signal advising the boat name and the number of people on board.
- 11.3 Boats may be inspected for compliance with the safety regulations at the discretion of the race committee
- 11.4 Skippers are required to maintain a written list on board of all crew for the day (including the skipper), their next-of-kin or contact person, and a contact phone number. All crew must be made aware of the location of this list before departing their mooring.

12.0 Insurance

12.1 Each participating boat shall be insured with valid third-party liability insurance.

13.0 After-Race Function

13.1 Notification of results and the presentation of prizes will be at the Clubhouse after the race. Hot food and refreshments will be available.

14.0 Disclaimer of Liability

14.1 Competitors participate entirely at their own risk. See RRS 4, Decision to Race. The responsibility for a boat's decision to participate in a race or to continue racing is hers alone.

14.2 The Organising Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

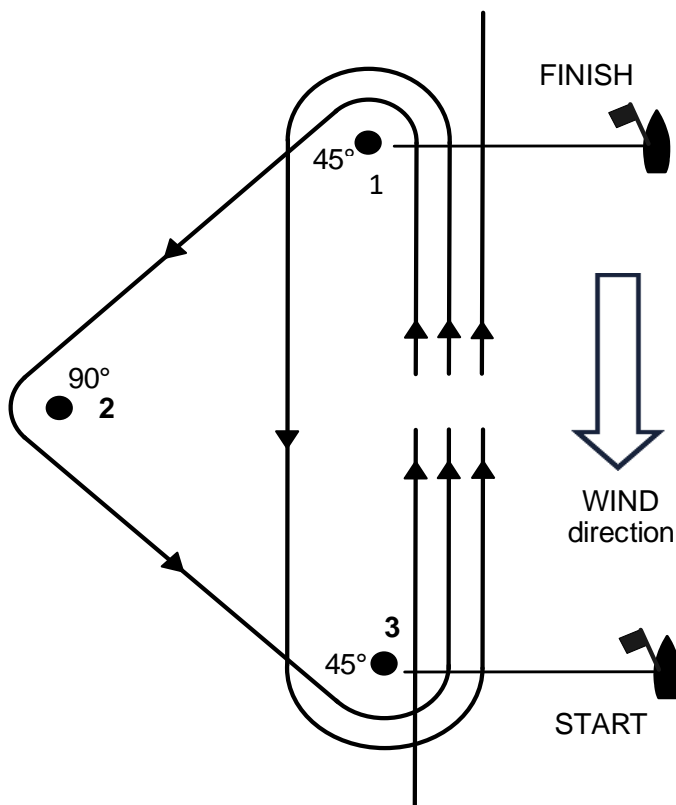
